

MEETING OF CONCRETE AGGREGATES CORPORATION**

The following were the highlights of the Special Stockholders' Meeting of Concrete Aggregates Corporation held on October 3, 2007 at the 2nd Floor, Ortigas Building, Ortigas Avenue, Ortigas Center, Pasig City at 9:00 in the morning:

Determination of Quorum

The Special Stockholders' Meeting was attended by stockholders (in person and by proxy) representing a total of 23,385,727 shares, or 85.142% of the 27,466,449 total outstanding shares of the Corporation.

Approval of the Sale by the Corporation of its Property located in Longos, Bagumbayan, Quezon City in favor of Ortigas & Company, Limited Partnership.

Upon presentation for ratification, the stockholders unanimously voted to approve the proposal of Ortigas & Company, Limited Partnership for the latter to purchase the Company's Property located in Longos, Bagumbayan, Quezon City with an area of approximately 12.47 hectares for the purchase of P1.13 billion payable under the terms agreed upon by the parties.
